Call to Order; Pledge of Allegiance & Invocation

Judge Fowler called the meeting to order and led everyone in the pledge of allegiance. Mr. Afflerbach gave the invocation.

New Business:

Executive/Closed Session (No. 1 & 3)

As presiding officer of the Commissioners Court, Judge Fowler called an executive session and announced the court is now in session at 9:10 a.m.

While the court was behind closed doors, the court took up the 2nd item of deliberation (Agenda Item No. 3) as well.

Judge Fowler announced that the executive sessions ended on September 11th at 9:38 a.m.

Discussion and Potential Action (No. 2)

MOTION: Mr. Pilchick made a motion to appoint Commissioner Kaiser as agent for the Commissioners Court to seek out and contract with a realtor for potential acquisition of real property in Commissioner Precinct Number 3. Mr. Afflerbach seconded the motion. Motion carried on a vote of 5-0.

Discussion and Potential Action (No. 4)

MOTION: Mr. Kaiser made a motion to appoint Ashley Holub as the Human Resources Director of DeWitt County effective October 1, 2023. Mr. Pilchick seconded the motion. Motion carried on a vote of 5-0.

MOTION: Mr. Pilchick made a motion to set a hearing date for establishing a 35 MPH speed limit on McElroy Road in Commissioner Precinct No. 2 on October 9, 2023 at 9:00 a.m. at the County Courthouse. Mr. Kaiser seconded the motion. Motion carried on a vote of 5-0.

MOTION: Mr. Kaiser made a motion to receive Order of Special Election and Notice of Special Election to be held November 7, 2023 and signed by County Judge Daryl L. Fowler. Mr. Pilchick seconded the motion. Motion carried on a vote of 5-0.


