## **DeWitt County reports new case of COVID-19**

DeWitt County is reporting a new case of COVID-19 in a county resident. This case brings the number of known cases to eight. The individual is a resident of Cuero and is presently hospitalized in Cuero. State health officials will not confirm the age or gender of the patient. How the patient obtained the virus is unknown to health department officials.

Currently, two patients are under investigation at Cuero regional Hospital. Six others are at home and awaiting test results. Other confirmed cases are quarantined at home. One of the known cases of the virus has recovered. No deaths attributable to COVID-19 have been reported in DeWitt County.

Texas Governor Greg Abbott has issued Executive Orders during this period of emergency. In EO GA-14 he directs citizens to "stay home" and "stay put" in order to slow the spread of COVID-19. Under the order of the governor, persons engaging in non-essential social gatherings, business operations, and other non-essential activities are subject to a fine up to \$1000 and/or 180 days in jail.

County Judge Daryl Fowler implores county residents to heed the order of the governor and the advice of the medical experts who strongly encourage citizens to keep a six-foot distance between each other to avoid spreading the virus. "For Heaven's sake, please stay home except for essential needs or essential work... and keep the children at home, too," pleads Judge Fowler.

"With Easter upon us, the spread of the virus is possible in family and social settings, so please reinforce the good hygiene and physical distancing if your family chooses to gather together," he adds.

Individuals may be exposed to COVID-19 and be infectious even when no symptoms are present. If you believe you have been exposed, monitor yourself closely for symptoms such as fever, cough, sore throat, and shortness of breath for 14 days after the exposure. If you experience

any of these symptoms and do not need urgent medical attention, isolate at home and contact your healthcare provider.

If an individual knows they have been exposed, they should not go to work. If a fever and cough are present, they should isolate themselves from others at home and monitor symptoms.

Minimizing exposure is especially important for people who are 65 or older or who have an underlying health condition like heart disease, lung disease, diabetes, high blood pressure or cancer. People in those groups have a higher risk of developing severe complications if they do get COVID-19, and the safest thing for them during an outbreak will be to stay home as much as possible and minimize close contact with other people. To get ready, they should talk to their doctor about getting additional prescription medications and have enough household items and groceries on hand to stay home as needed.

The judge and emergency management personnel are communicating daily with state officials and regional leaders about the spread of the COVID-19 virus and referring callers to the official websites of the Centers for Disease Control and the Texas Department of State Health Services. These websites are great resources for the general public according to Judge Fowler.
