## Call to Order; Pledge of Allegiance & Invocation

Judge Fowler called the meeting to order and led everyone in the pledge of allegiance. Mr. Afflerbach gave the invocation.

## Proclamation for German-American Day (No. 1)

Commissioner Precinct No. 1 reported Hahn Road (CTIF grant road) stabilization done and requisition in for grid. Von Haefen Road is getting slicked off, has been stabilized and next step will be seal oil and paving. Elder Road is being grinded, setting culvert pipes and replacing cattle guard.

Commissioner Precinct No. 2 reported on first coat of rock on Cattleguard Road (CTIF grant road) and waiting to see what the weather to put the second coat.

Commissioner Precinct No. 3 reported on working on getting Plasczyk Road ready to be paved.

Commissioner Precinct No. 4 reported on Thomaston River Road (CTIF grant road) and by this afternoon should have approximately 3.2 miles paved.

Mr. Afflerbach reported that the commissioners are having problems with Pub Works program. The program has been updated and there are some glitches. Assistant IT Administrator Shelly Parker reached out to Ryan Varela for assistance since he was familiar with the program. Mr. Varela has step-by-step instructions of what needs to be done that he can provide all commissioners.

Mr. Pilchiek advised that the distributor truck had to be taken in for repairs. Since Commissioner Precinct 2 and Commissioner Precinct 3 have mainly used the truck, those two commissioners will pay the cost of the repairs.
