DeWitt County Commissioners Court met in regular session June 12, 2023 at 9:00 a.m. in the County Courtroom at the DeWitt County Courthouse in Cuero, Texas, with the following members present:

Call to Order; Pledge of Allegiance & Invocation

Judge Fowler called the meeting to order and led everyone in the pledge of allegiance. Mr. Afflerbach gave the invocation.

New Business:

Executive/Closed Session (No. 1)

Judge Fowler announced that the court would be going into an executive session with the county's attorney at 9:05 a.m. for agenda items number 1 & 2.

Judge Fowler announced that the court ended the executive session with the county's attorney ended on this date, June 12, 2023, at 9:30 a.m. and returned to an open session to take up pending business that may have risen from the discussion in the executive session.

Discussion and Potential Action (No. 2)

MOTION: Mr. Afflerbach made a motion that Order Number 2023-015 be approved by the DeWitt County Commissioners Court approving a corrected subdivision plat of the town of Westhoff, Texas located in the unincorporated area of DeWitt County, Texas; accepting Carter Avenue (a dedicated public road depicted and described on said plat) for all purposes into the county's public road and bridge system; and establishing an effective date and compliance with the Texas Open Meeting Act. Mr. Afflerbach did not have any information to update on the DeWitt County Historical Museum.

Mr. Afflerbach inquired about the clock in the bell tower not working. Judge Fowler was contacted by someone from up north and that person is planning on swinging through Texas and wanted to take a look at the clock.

Legislative Update (No. 27)

Judge Fowler reported that there is currently a special session going on which is limited to property tax issues. There is a hangover bill that was approved by both chambers is sitting on the Governor's desk right now that would amend Texas Property Code and restrict Commissioners Court ability to regulate flag lots in subdivisions. If the Governor allow it to become law, the county would have to go back to the drawing board and strip that out of the county's subdivision regulations.

Mr. Afflerbach reported that the roof and fascia boards are finished at the DeWitt County Historical Museum. The contractor and Weaver & Jacobs been in discussion with the architect and the Texas Historical Commission regarding the gutters.

Judge Fowler discussed a phone call he had with Steve Holzheauser to discuss the last Legislative session and where the county will go with Mr. Holzheauser since there weren't really any bills that the county had proposed and were advocating as part of the county's coalition.

Commissioner Precinct No. 4 reported on shredding and still fixing wash outs. A culvert gave away on Friar Road because of the excessive number of gravel trucks going through in support of the solar project.

Texas Emergency Management County Liaison Officer Kevin Lamprecht addressed the court regarding a public website access for reporting public entity damages. A workshop will be scheduled in the future for training.
