SFHA-3	<ul style="list-style-type: none"> <li>• Building of &lt;2000 sq. ft. Residential Structure</li> <li>• Placement of Manufactured Home</li> <li>• 1000 sq. ft. Barn (any type) or Shop without Restroom</li> <li>• Substantial Improvement &gt;1000 sq. ft.</li> </ul>	\$200.00

PIPE-2	<ul style="list-style-type: none"> <li>• Pipeline Development</li> </ul>	
PIPE-3	<ul style="list-style-type: none"> <li>• Agricultural Lines for Irrigation Purposes with diameter <b>greater than two (2) inches.</b></li> </ul>	
PIPE-4	<ul style="list-style-type: none"> <li>• Engineering Services – Per Review</li> </ul>	\$250.00

**Floodplain Development Permit Fees OUTSIDE Special Flood Hazard Areas (SFHA):**

DP-1	<ul style="list-style-type: none"> <li>• Issuance of Permit Package for placement of structures or manufactured homes which have been determined by the Floodplain Administration to be outside the SFHA (to cover cost of printing supplies); includes Information Letter (exemption letter); Development Permit; Utility Permit</li> </ul>	\$20.00
DP-2	<ul style="list-style-type: none"> <li>• Issuance of Firmette and Information Letter only for structures or manufactured homes which have been determined by the Floodplain Administration to be outside the SFHA</li> </ul>	\$10.00
DP-3	<ul style="list-style-type: none"> <li>• Issuance of Firmette for informational purposes only</li> </ul>	\$10.00
