DeWitt County reports new cases of COVID-19

County health officials are reporting five new cases of coronavirus. All of the individuals are isolated and recovering at home.

Case number 38 is a 36 year-old male with a rural address in the Cuero zip code. His infection is attributable to community spread and possibly related to out-of-town travel.

Case number 39 is a 60-year old female with a rural address in the Yorktown zip code. Her infection is attributable to community spread and possibly related to work-related travel out of the county.

Case number 40 is a 55 year-old female living in the city of Yoakum. Her exposure is work related.

Case number 41 is a 26 year-old female living in Yorktown. Her infection is attributable to community spread with known travel to Corpus Christi.

Case number 42 is a 53 year-old female with a rural address in the Yoakum zip code. Her exposure is attributable to a family member who came to visit and subsequently tested positive for the coronavirus.

A total of 42 cases have been diagnosed in DeWitt County since Governor Greg Abbott declared a state of emergency on March 13, 2020. Nineteen, including these diagnosed cases, are isolating at home. Four are in patients of medical facilities in Victoria. Eighteen have recovered. One death in the county is attributed to COVID-19 infection of an individual with a comorbidity.

Throughout DSHS Region 8 which covers 28 counties east and west of San Antonio and includes an estimated population of 3.1 million people, a total of 7,406 cases have been confirmed since tracking began. More than 3,700 of the individuals diagnosed with the coronavirus have recovered. The region reports 130 deaths through June 19. DSHS Region 8 is tracking additional categories of probable infections and those that are pending investigation. Those numbers are not included in this publication.

In an effort to slow the spread of this infectious disease, Texas Governor Greg Abbott has issued Executive Orders during this period of emergency. In EO GA-14 he directs citizens to “stay home” and “stay safe.” More recent Executive Orders are directed at reopening the Texas economy in a safe and deliberate manner.

Individuals may be exposed to COVID-19 and be infectious even when no symptoms are present. If you believe you have been exposed, monitor yourself closely for symptoms such as fever, cough, sore throat, and shortness of breath for 14 days after the exposure. If you experience any of these symptoms and do not need urgent medical attention, isolate at home and contact your healthcare provider.

If an individual knows they have been exposed, they should not go to work. If a fever and cough are present, they should isolate themselves from others at home and monitor symptoms.

Minimizing exposure is especially important for people who are 65 or older or who have an underlying health condition like heart disease, lung disease, diabetes, high blood pressure or cancer. People in those groups have a higher risk of developing severe complications if they do get COVID-19, and the safest thing for them during an outbreak will be to stay home as much as possible and minimize close contact with other people. To get ready, they should talk to their doctor about getting additional prescription medications and have enough household items and groceries on hand to stay home as needed.

The judge and emergency management personnel are communicating daily with state officials and regional leaders about the spread of the COVID-19 virus and referring callers to the official websites of the Centers for Disease Control and the Texas Department of State Health Services. These websites are great resources for the general public according to Judge Fowler.
