

NOTICE OF PUBLIC HEARING ON TAX INCREASE

A tax rate of \$0.38576 per \$100 valuation has been proposed by the governing body of DeWitt County.

PROPOSED TAX RATE	\$0.38576 per \$100
NO-NEW-REVENUE TAX RATE	\$0.37235 per \$100
VOTER-APPROVAL TAX RATE	\$0.38576 per \$100

The no-new-revenue tax rate is the tax rate for the 2025 tax year that will raise the same amount of property tax revenue for DeWitt County from the same properties in both the 2024 tax year and the 2025 tax year.

The voter-approval rate is the highest tax rate that DeWitt County may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that DeWitt County is proposing to increase property taxes for the 2025 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON September 22, 2025 AT 9:00 AM AT the De Witt County Courthouse, 1st floor Courtroom, 307 N. Gonzales St, Cuero, TX.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, DeWitt County is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Commissioner's Court of DeWitt County at their offices or by attending the public hearing mentioned above. YOUR TAXES OWED UNDER ANY OF THE RATES MENTIONED ABOVE CAN BE CALCULATED AS FOLLOWS:

The 86th Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.

The following table compares the taxes imposed on the average residence homestead by DeWitt County last year to the taxes proposed to be imposed on the average residence homestead by DeWitt County this year.

No-New-Revenue Maintenance and Operations Rate Adjustments

State Criminal Justice Mandate

The DeWitt County Auditor certifies that DeWitt County has spent \$162,883 in the previous 12 months for the maintenance and operations cost of keeping inmates sentenced to the Texas Department of Criminal Justice. DeWitt County Sheriff has provided DeWitt County information on these costs, minus the state revenues received for reimbursement of such costs. This increased the no-new-revenue maintenance and operations rate by \$0.00033/\$100.
