

NOTICE OF PUBLIC HEARING ON TAX INCREASE

A tax rate of \$0.42243 per \$100 valuation has been proposed by the governing body of DeWitt County.

PROPOSED TAX RATE	\$0.42243 per \$100
NO-NEW-REVENUE TAX RATE	\$0.28378 per \$100
VOTER-APPROVAL TAX RATE	\$0.53043 per \$100

The no-new-revenue tax rate is the tax rate for the 2022 tax year that will raise the same amount of property tax revenue for DeWitt County from the same properties in both the 2021 tax year and the 2022 tax year.

The voter-approval rate is the highest tax rate that DeWitt County may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that DeWitt County is proposing to increase property taxes for the 2022 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON August 22, 2022 AT 09:00 AM AT the DeWitt County Courthouse, First Floor Courtroom, 307 N Gonzales St, Cuero, TX 77954.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, DeWitt County is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Commissioner's Court of DeWitt County at their offices or by attending the public hearing mentioned above. YOUR TAXES OWED UNDER ANY OF THE RATES MENTIONED ABOVE CAN BE CALCULATED AS FOLLOWS:

$$\text{Property tax amount} = (\text{tax rate}) \times (\text{taxable value of your property}) / 100$$

The 86th Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.

No-New-Revenue Maintenance and Operations Rate Adjustments

State Criminal Justice Mandate

The DeWitt County County Auditor certifies that DeWitt County County has spent \$101,240 in the previous 12 months for the maintenance and operations cost of keeping inmates sentenced to the Texas Department of Criminal Justice. DeWitt County County Sheriff has provided DeWitt County information on these costs, minus the state revenues received for reimbursement of such costs. This increased the no-new-revenue maintenance and operations rate by \$0.00050/\$100.

Indigent Defense Compensation Expenditures

The DeWitt County spent \$275,964 from July 1, 2021 to June 30, 2022 to provide appointed counsel for indigent individuals in criminal or civil proceedings in accordance with the schedule of fees adopted under Article 26.05, Code of Criminal Procedure and to fund the operations of a public defender's office under Article 26.044, Code of Criminal Procedure, less the amount of any state grants received. For the current tax year, the amount of increase above last year's indigent defense compensation expenditures is \$57,759. This increased the no-new-revenue maintenance and operations rate by \$0.00016/\$100.
