- Engine: Minimum 440 HP, with at least 1,850 lb-ft torque
- **Transmission:** Heavy-duty automatic, minimum 12-speed, with multi-speed reverse capability

- Rear Suspension: Minimum 40,000 lb rated heavy-duty suspension
- Heavy-duty frame rails, minimum 11.75 inches tall
