Judge Fowler has received something from Allison & Bass this morning. Significant deadlines are looming this week if not today to get Senate Bills out of House Committees. SB 175 is still pending in the House Committee on State Affairs. If it does not get voted out this week it will most likely die.

There are some other bills that are still pending that the counties hope will pass. Those are bills that will force the State of Texas to compensate counties for certain mental health patients in our jails and certain juveniles that are in detention and awaiting transfer to state facilities.

## Discussion of Commissioner Precinct Operations (No. 29)

Commissioner Precinct No. 1 was absent.

Commissioner Precinct No. 2 reported on the bridge on Dagg Road is all poured, waiting for it to dry and cure, guardrail work and are ripping up that road for repair.

Commissioner Precinct No. 3 reported on finished blacktopping Old Cuero Road, which is now completely done. The rest of this week is repairing roads that the rain tore up.

Commissioner Precinct No. 4 reported on a tree that had fallen on Fox Crossing Road after the rain before last and have trimmed it up. Old Goliad Road is open again hot mixed over the culverts and are supposed to be pouring the sides of them this week.

Judge Fowler reported that he had contacted a contractor, Chip Dents with East End Builders, to perform work on the window sashes on the north and south windows of the fourth floors beneath the bell mechanism. The glass of one sash had slipped about 8-10 inches and allowing rain water to enter the belfry. Temporary plywood has been installed while the repair is being done.

Mr. Afflerbach reported that the roof and fascia boards are on at the DeWitt County Historical Museum. Cox Brothers and Karl Komatsu with Komatsu Architects are working on the design of the gutters. County is waiting for final specs on design changes of removing some windows, replacing siding and re-working windows from the architect before we can move forward with this step.

## Discussion of Commissioner Precinct Operations (No. 25)

Ricky Gohmert addressed the court with a suggestion that the county hire a full time engineer. Mr. Gohmert discussed having water crossing at the intersection of River Road and Old Goliad Road. The county serviced the road & put hot mix at the intersection, installed a low water crossing up the hill instead of putting it where the water comes over the road. The first good rain caused the water to back up at his cattle guard. The big rain came, the water backed up at this cattle guard and through his neighbor's property. If the county would have a staffed engineer that would work with the four (4) commissioners, he thinks that is the route that the county has to go because there is a lot of money being spent on somebody and it is not on the county roads.

Clifford Diebel addressed the court regarding the flood water damage caused by the new box culvert installed on Meyersville-Mission Valley Road near his property and is concerned about the destruction of trees and creek bank.

Commissioner Precinct No. 1 reported on a guardrail that washed off on Mueller Road. The guardrail is temporarily being repaired because TxDOT is contracted to rebuild the bridge. Crews are working on washouts on the road from the recent rain.

Commissioner Precinct No. 2 reported on double shot seal coats on Horseshoe Road. The road has been improved from a Class C road to a Class A road. Crews started to re-seal coat a couple of roads out the other way. Dagg Road we should probably have the bridge open Tuesday or Wednesday, will be doing some fill in on each side of the bridge and re-pave the road.

Commissioner Precinct No. 3 reported on crews re-doing what had washed out, which was probably 80% of the roads and putting limestone back. He is having to wait for the limestone to dry out because the creek in town came up and the water was about half way up the stock pile at the yard on 12<sup>th</sup> Street. He reported on a waste management burm on Hohn Road that had washed out and came across the county road which the crews had to clean up.

Commissioner Precinct No. 4 reported that most roads had flood damage. He also reported that a guardrail was washed off a bridge on Fordtran Road. McMahan Welding is trying to re-attach the guardrail.

Court discussed Texas Department of Emergency Management request for the commissioners to track damage due to recent heavy rainfall.
