Accounts Payable (No. 28)

Ratified Accounts Payable (No. 29)

MOTION: Mr. Kaiser made a motion to approve ratified accounts payable. Mr. Pilchiek seconded the motion. Motion carried on a vote of 5-0.

Payroll Reports (No. 30)

MOTION: Mr. Kaiser made a motion to receive and ratify payroll reports approval. Mr. Pilchiek seconded the motion. Motion carried on a vote of 5-0.

Courthouse/Annex/Museum Expenditures/Maintenance/Improvements (No. 31)

Judge Fowler reported that Trane performed some service work last week. The lightning storm that came in with the previous front messed up the controls in the chiller and had to be reset, actuators in various air handlers of the courthouse were not working and had to be replaced, and a belt is missing or broken above the County Attorney's office and will work on it pretty quick.

Judge Fowler reported that the roof was repaired over the balcony.

Judge Fowler reported that a gentleman left his business card for pressure washing.

Judge Fowler reported that Commissioner Precinct No. 1 has removed one (1) of the pavers in front of the 2022 DeWitt County Annex building. Mr. Varela reported that the county is short on pavers and he has reached out to Weaver and Jacobs to see if the can locate some more.

Executive and Closed Session (No. 1)

An executive and closed session meeting was held regarding the following matters pertaining to that certain tract or parcel of real property currently owned by De Witt County, containing 100.0 acres more or less ("Subject Property"), being and situated in De Witt County, Texas, a part of the Samuel Lockhart League (A-28) therein: pursuant to sections 551.071(2) and 551.129 of the Texas Government Code (consultation with attorneys), for the Commissioners Court to consult with and seek advice from its attorneys regarding legal issues related to a proposed sale, donation, or other transfer of the Subject Property to a third-person or third-party for worthwhile public purposes, including the economic development of the county and surrounding region; pursuant to section 551.087 of the Texas Government Code (economic development negotiations), for the Commissioners Court to (i) discuss or deliberate regarding commercial or financial information the Commissioners Court has received from and/or regarding a third-person or third-party business prospect that the Commissioners Court is considering to have locate, stay, or expand in De Witt County, Texas and with which the Commissioners Court is conducting economic development negotiations, and (ii) deliberate the offer of a financial or other incentive to or from said business prospect for a proposed economic development project to be located in said county; pursuant to section 551.072 of the Texas Government Code (deliberation regarding real property), for the Commissioners Court to deliberate the purchase, exchange, lease, or value of real property since deliberation of those matters in an open meeting would have a detrimental effect on the position of the Commissioners Court in negotiations with a third-person or third-party; and pursuant to section 551.0725 of the Texas Government Code (deliberation regarding contract being negotiated), for the Commissioners Court to deliberate business and financial issues relating to a contract being negotiated between De Witt County and a third-person or third-party, provided that (i) the Commissioners Court must first vote unanimously that deliberation in an open meeting of those matters would have a detrimental effect on the position of the Commissioners Court in negotiations with the third-person or third-party, and (ii) the attorney advising the Commissioners Court must have issued a written determination that deliberation in an open meeting of those matters would have a detrimental effect on the position of the Commissioners Court in negotiations with the third-person or third-party.

MOTION: Mr. Kaiser made a motion to go into an executive/closed session to deliberate on matter that could have a detrimental to the Commissioners Court in negotiations with the third-person or third-party and also that the judge would be the keeper of the certified agenda. Mr. Pilchiek seconded the motion.

Judge Fowler reported that currently debating among each other about the proper disposition of the 100 acres of land and the county has a little attorney work to do before the county can convey.
