Call to Order; Pledge of Allegiance & Invocation

Judge Fowler called the meeting to order and led everyone in the pledge of allegiance. Mr. Randle gave the invocation.

MOTION: Mr. Kaiser made a motion to appoint a total of seventeen (17) election clerks for General and Special Elections for a 2-year term beginning October 1, 2020. Mr. Pilchiek seconded the motion. Motion carried on a vote of 5-0.

DeWitt County Drainage District No. 1 Budget (No. 2)

MOTION: Mr. Pilchiek made a motion to receive the FY2021 Budget and the FY2021 Order Setting Salaries of the commissioners and employees of DeWitt County Drainage District No. 1. Mr. Kaiser seconded the motion. Motion carried on a vote of 5-0.

Texas Water Development Board Flood Infrastructure Fund (No. 3)

Court heard a presentation from Doug Sethness regarding DeWitt County Drainage District No. 1's submission to obtain a grant from the Flood Infrastructure Fund. Court did not take any action on this agenda item.

Call to Order; Pledge of Allegiance & Invocation

Judge Fowler called the meeting to order and led everyone in the pledge of allegiance. Mr. Afflerbach gave the invocation.

Cares Act/CRF Grant (No. 1)

Ms. Carson advised that her office was still working on back indexing and scanning of the birth, death and marriage records; therefore, the indexes would not be made available online at this time.
