- Current Vacation and Sick time as of September 30, 2021 will be rolled into a PTO bank for each employee.
- Current Excused time will be depleted and 56 hours will be added to each employee’s PTO bank on October 1, 2021, only during the 2021 transition year.
- On October 1, 2021, a transition plan to prorate Vacation time will be added to the employee’s PTO bank as follows and duly noted on the schedules as shown:

Mr. Afflerbach requested that the county budget \$100,000.00 for the Historical Museum repairs.

Mr. Randle addressed his concerns with the IT Administrator receiving an increase in salary when no one else was receiving an increase in salary.

MOTION: Mr. Randle made a motion to modify the budget as presented to reflect the salary of IT Administrator remain the same as it was in the FY2021 budget year.

Mr. Randle's comment was that he could not vote in good conscious on this budget allowing a 3.6% raise to one individual hourly employee when the county is denying all other hourly employees from getting a raise.


MOTION: Mr. Randle made a motion that hourly employees wages subject to no raises across the board for the county.
