Call to Order; Pledge of Allegiance & Invocation

Judge Fowler called the meeting to order and led everyone in the pledge of allegiance. Mr. Afflerbach gave the invocation.

New Business:

General Land Office Grant (No. 1)

MOTIN: Mr. Randle made a motion to approve the application for \$500,000 grant from the General Land Office (GLO) and authorize the county judge to submit the application and administer it. Mr. Afflerbach seconded the motion. Motion carried on a vote of 5-0.

File Conversion Services Agreement (No. 2)

MOTION: Mr. Kaiser made a motion to give permission to DataBank for document preparation and scanning services for Justice of the Peace Precinct No. 2 and authorize Judge to sign the commencement to begin work. Mr. Pilchiek seconded the motion. Motion carried on a vote of 5-0.

Video Magistrate Service Agreement (No. 3)

Sheriffs' and Constables' Fees Update (No. 10)

MOTION: Mr. Kaiser made a motion to adopt of Sheriffs' and Constables' updated fees for 2023 with no changes as required by local Government Code 118.131. Mr. Pilchiek seconded the motion. Motion carried on a vote of 5-0.
