DeWitt County Commissioners Court met in regular session July 10, 2023 at 9:00 a.m. in the County Courtroom at the DeWitt County Courthouse in Cuero, Texas, with the following members present:

County Judge Daryl L. Fowler Commissioner Curtis Afflerbach, Precinct No. 1 Commissioner James B. Pilchiek, Precinct No. 2 Commissioner James Kaiser, Precinct No. 3 Commissioner Brian Carson, Precinct No. 4

Call to Order; Pledge of Allegiance & Invocation

Judge Fowler called the meeting to order and led everyone in the pledge of allegiance. Mr. Afflerbach gave the invocation.

New Business:

Public Hearing (No. 1)

Public hearing held in order to provide opportunity for public comments on establishing a 40 MPH speed limit on Horseshoe Road in Commissioner Precinct No. 2. No one was present to speak for or against.

Close Public Hearing (No. 2)

Judge Fowler closed the public hearing.

Rule on Public Hearing (No. 3)

MOTION: Mr. Pilchiek made a motion establishing a 40 MPH speed limit on Horseshoe Road in Commissioner Precinct No. 2 as soon as the signs are installed. Mr. Kaiser seconded the motion. Motion carried on a vote of 5-0.

Courthouse/Annex/Museum Expenditures/Maintenance/Improvements (No. 31)

County Auditor Carrie Rea reported that there was an issue with the air conditioner in the treasurer's office at the annex building. Victoria Air ordered fuses and then discovered that the compressor was out.

Mr. Afflerbach reported on the following regarding the DeWitt County Historical Museum:

- 1. Experiencing problems with the upstairs air conditioner; GVEC repaired the unit but the thermostat was still showing high temperatures. GVEC discovered that the duct work is totally destroyed. Consensus of the court that Mr. Afflerbach turn this project over to Weaver & Jacobs to see about looking into the duct issues.
- 2. Addressing a stain that appeared on the wall that they think is from the roof failure. They having that cleaned up and re-painted the wall.
- 3. Still waiting on the architect regarding continuing work on the walls.

Judge Fowler reported that the painting contractor will start painting at the Weber Annex Building this week.

County Auditor Carrie Rea discussed the road maintenance and road asphalt bids. The court will need to decide next month whether to extend or go out for new bids.

Legislative Update (No. 32)

Judge Fowler reached out to Steve Holzheauser to get commitment for an extension of the professional services contract. The McMullen County Judge spoke with judge about there being

new county judges in the west side counties of the Eagle Ford Shale and that it would be a good idea to expand the coalition to those counties to share cost of the professional service contract.

Discussion of Commissioner Precinct Operations (No. 33)

Commissioner Precinct No. 1 reported on being in the process of building a match project bridge on Old Gonzales Road. One has been completed and are currently on the second one. Plans on working on the section of the Old Gonzales Road from the city limits to the railroad tracks. TxDOT is still working on Hwy 87 at Nolte Boehl Road.

Commissioner Precinct No. 2 reported on finishing a low water crossing concrete work on Kaiser Road over the weekend. Mr. Pilchiek is hoping by August 16th to have the road opened up to traffic.

Commissioner Precinct No. 3 reported on normal maintenance work.

Commissioner Precinct No. 4 reported on a contractor re-working Fordtran Road up to Wolf Hollow Road up to Bialek Road and back to Friar Road.
