Judge Fowler reported that he has contacted Curtis Stoddard regarding a little bit of water filtration into the basement of the courthouse after the recent 8 inches of rain.

Judge Fowler reported that he has reached out to the roofing contractor. With the recent 8 inches of rain, there was water from the second floor balcony running down onto the porch.

Judge Fowler reported that last week there were two (2) formal US Marshals conducted an audit of the courthouse security at the request of the county. There was a court proceeding going on during their audit and should be receiving the report probably within 90 days. This report will should have a list and action plan that the county can adopt to start moving forward with some additional security measures.

Judge Fowler reported on a request, at the Weber Annex, the double glass doors are not doors with push bar exists and have a dead bolt lock.

Judge Fowler reported that he had a contractor remove the water fountains located in the Weber Annex near the bathrooms. He will be reaching out to a plumber to replace some faucets in the ladies bathroom.

Judge Fowler reported that he had reached out to Garcia's Lawn Service to remove the two (2) dead palm trees that died from the freeze two years ago.

Curtis Afflerbach gave an update to the court regarding the DeWitt County Museum projects that he had been working on while serving as Commissioner Precinct No. 1. Mr. Afflerbach and Ryan Varela met with the ladies from the museum and went over the exterior drawings with the architect. The architect will make the changes and submit them to the historical commission. It was decided to not have the architect submit the landscaping drawings. The landscaping drawings will need to be presented to the court for review.

Legislative Update (No. 51)

Commissioner Precinct No. 3 reported on work on Ckodre Road building up road base, 800 loads of limestone were put on that road at a cost of around \$500,000.00 and getting ready to pave Ckodre Road as soon as the weather permits.

Commissioner Precinct No. 4 reported on repairing washouts from the recent rain and putting Portland cement on Wolf Hollow Road tomorrow. Mr. Carson reported that some of the rock baskets in the creek washed out from the recent rains on the Mission Valley Road at the Clifford Diebel place.
