Judge Fowler called the meeting to order and led everyone in the pledge of allegiance. Mr. Afflerbach gave the invocation.

# Garrett Road at Chicolete Creek Road Closure (No. 2)

Court discussed road closure and bridge replacement on Garrett Road at Chicolete Creek and sign form for TXDOT. Mr. Pilchiek advised the court that he had notified the property owner of the fence encroachment into county right of way and that the property owner got his permission to put the fence back the way it belongs when the project is complete.
