For each Livestock Estray – Sheriff's Fee

**Hauling (for single load) \$100.00**

*Livestock estray fees add 0.56 cents per mile*

**Feed, per day/per head**

For Cattle	\$10.00
For horses/mules	\$10.00
For goats/sheep	\$5.00
For hogs	\$5.00

**Catch Fee**

For contained area/per head	\$25.00
Additional fee if horse is required to catch estray	\$100.00
County Fee/per head	\$25.00

**Collecting Money on an Execution of Order of Sale when the same is made by a sale:**

**for the first \$200.00 or less, 10 percent;**

**for all sums over \$200.00 and not exceeding \$1,000.00, 6 percent;**

**for all sums over \$1,000.00 and not exceeding \$5,000.00, 3 percent;**

**for all sums over \$5,000.00, 2 percent.**

**However, in the case where the sum is exorbitant, commissioners' court may adjust the fee.**

**When the money is collected by a sheriff or constable without a sale, half of the above rates shall be allowed.**
